The other parts of the program include Counseling, Education and Skills Development. These programs serve every mother and every child in our program, which was 26 Moms and 44 children in 2024.

In response to the growing crisis caused by the high cost of living we offer one of the fastest solutions to preventing homelessness - by subsidizing housing and other basic needs to help stabilitze families and keep them together. In 2024 Hearts for Moms has subsidized rent and basic needs for 15 Moms and 25 children. The housing program helps cover rent, utilities, groceries and furnishings. Our basic needs program provides diapers, wipes, formula, furnishings, clothing, medical and dental services as well as strollers and car seats.
